

## **Warranty period:**

The Sherco Company grants a contractual guarantee for a fixed period of time depending on the vehicle, these conditions are shown below.

This period starts from the day the vehicle is sold by the Sherco Dealer to the final customer. To ensure that the sale date is accurate, which establishes the starting date of the guarantee, the Sherco Dealer will register the vehicle on the Sherco dealer network on the day of the sale.

### **Terms of the Warranty:**

Warranty will be provided at the discretion of Sherco as recognized by Sherco or the authorized dealer. It is expressly agreed between the parties that the responsibility for Sherco is strictly limited, and again at the discretion of Sherco, especially when it comes to repairing non-compliant vehicles.

In the repair process of the vehicle by the Dealer or a member of their distribution network, Sherco will only bear the cost of labor based on the time schedule attached. The hourly rate is set at €20 per hour.

If a defective part is removed and taken as collateral, it shall be retained by the authorized Dealer under the identical conditions as defined by Sherco for the sale of Sherco products. **Namely parts on order are independent of the warranty procedure.** 

After Sherco accepts the warranty claim a refund of the purchase price of the defective part will be paid in the form of a **credit deducted from outstanding invoices**. The Sherco warranty applies to the vehicle. Therefore, the transfer of ownership does not change the conditions of this warranty.

In order to obtain warranty service, the owner will be required to show that all of the maintenance recommendations and procedures recommended by the manufacturer and outlined in the owners manual have been performed.

Every Sherco vehicle comes with an owners manual.

Warranty repair work must be conducted under the supervision and in the workshop of an authorized Sherco dealer.

Note that all dealers who sell Sherco are not necessarily authorized Sherco dealers and they may not be able to repair the entire Sherco range.

The exchange or repair of any part found to be defective is left to the discretion of Sherco.

# **Limitations of the Warranty:**

#### The warranty is not in effect by Sherco if it is proved that the defect is the result of any of the following:

- The vehicle has not been maintained properly and that such instructions concerning the treatment, maintenance or caring for the latter, which are provided in the owners manual, have not been met.
- Non Sherco parts were installed, changes or adjustments were made to the vehicle that are not authorized or provided by the manufacturer.
- The user prepared, modified or maintained the vehicle in a workshop outside of the Sherco network.
- The vehicle was used in an unusual way (for example: it was used in competitive sports, it was overloaded, even for a short period of time, it was stored in poor storage conditions).
- The damage is the result of normal wear and tear.

### **Warranty Exclusions:**

#### The Sherco warranty does not cover the following:

- The normal wear parts such as tires, cables, plugs, suppressors, bulbs, chains and sprockets, brake shoes and pads, clutch, air filter, muffler (internal corrosion) ...
- Siezures, holes in pistons caused by low oil level or the use the incorrect lubricant or the wrong fuel.
- Maintenance costs, maintenance work because of periodic revisions.
- Consumables, as well as those items relating to troubleshooting (such as transporting of the vehicle, telecommunications, subsistence, lodging, travel ...), the damage to property or cargo, and other financial losses (such as loss of enjoyment, loss of income, loss of time and the like).

**IMPORTANT:** The use of non-original parts or modified Sherco systems eliminates any possibility of a warranty.

Furthermore, if these changes tend to increase noise, power and speed, they are the owner's responsibility with respect to the law.

**NOTE:** Sherco guarantees replacement parts, on the same legal basis as their other products and according to the information contained in the list of the products and spare parts.
